







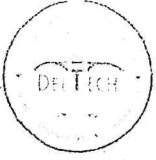

MINUTES OF THE MEETING

A meeting of Student's Grievance Redressal Committee (SGRC) was convened today. The attendance record of the meeting enclosed. During the meeting a complaint received through Chief Vigilance Office (CVO) vide I.D. Note letter No. F.DTU/Vig./Comp.49/2023/291 dated 30.10.2023 with enclosures was discussed. The original representation by few hostellers without their identity i.e. (Roll No., Branch Name, Hostel Name,) etc. was addressed to Honorable Lieutenant Governor, NCT of Delhi having following concerns: (i) ever increasing fees and hostel charges in DTU (ii) Chief Warden insisting to deposit entire hostel charges and mess charges (iii) insensitivity of Registrar (iv) incompetent staff and corrupt officers enjoying administration without any fear of higher authorities etc.

The above representation was shown to all the members of the Committee and was discussed. The Committee referred to the provision no. 05 of the UGC Gazette Notification which deals with SGRC. As per the provisions of this UGC Gazette Notification dated 11th April, 2023 complaint from an aggrieved students relating to the institution shall be addressed to the Chairperson (SGRC). Further, if any student aggrieved by the decision of the SGRC may refer an appeal to the Ombudsperson, within a period of 15 days from the date of receipt of such decision.

As the student has already approached directly to Lt. Governor (vide diary no.28275 dated 11.08.2023) and the matter reported to Vice Chancellor through DTTE letter No.F.1(321)Misc/DTU/SB/DTTE/2021/1990 dated 13.09.2023 the Committee was unanimous that there appears no role of SGRC in view of the above provisions of Gazette Notification. Further, after deliberations on the complaint the Committee was of the opinion that the matter in the complaint is related to practices followed in the hostel and University involving finance i.e. hostel fee, mess fee etc. Therefore, the matter does not directly concern with the SGRC as per the UGC Gazette Notification, and thus it may be referred back appropriately. The Committee authorized Chairman to appropriately give suitable response in line with the above for the I.D. Note dated 30.10.2023 of the Chief Vigilance Officer (CVO).

The Meeting ended with the vote of thanks to the Chair.
